About Us

The Black Public Defenders Association (BPDA) is a movement-led organization that supports a national network of skilled Black defenders (trial-attorneys, social workers, investigators, civil defense, immigration, family defense, and client advocates) who fight against mass incarceration and other racist carceral systems. Building a pipeline of Black defenders is one of our core pillars.

About the Fellowship

The BPDA Law School Fellowship Program aims to provide training and support to Black law students who are passionate about serving their communities through a career in public defense. One of BPDA Law School Engagement Committee's central goals is to provide resources that ensure that Black law students are able to access and succeed in public defense as a profession that empowers marginalized communities. Each year, the Committee selects a number of promising Black law students to serve as BPDA Summer Fellows. Each Fellow receives mentorship, intensive skills training, and financial support that enables them to successfully complete a paid summer internship at a public defender office and be well positioned for post-graduate employment. Each fellowship host site provides their students with a stipend up to \$5,000.

Housing Stipend

A housing stipend may be available based on demonstrated need. Please note that funds are limited and will be distributed accordingly.

The City of Atlanta Office of the Public Defender is pleased to offer a Legal Internship Program designed for rising 3L law students who are interested in criminal defense, public interest law, and serving their communities. The program provides law students with a meaningful, hands-on opportunity to gain practical legal experience while working alongside experienced public defenders and legal professionals.

Interns will be exposed to the day-to-day practice of criminal defense and will have the opportunity to develop and strengthen essential legal skills, including legal research, legal writing, litigation, client advocacy, case preparation, and courtroom advocacy.

Through this internship, students may have the opportunity to:

- Gain practical experience in criminal defense litigation, including criminal and traffic matters;
- Assist attorneys with trial preparation, including case investigation, discovery review, legal research, and preparation of motions and other legal documents;
- Conduct legal research and assist with drafting motions, pleadings, memoranda, and other legal documents;
- Observe and, when appropriate, participate in court proceedings, hearings, and trials;
- Develop skills in client interviewing, case assessment, and zealous advocacy;
- Learn about the role and responsibilities of a public defender and the constitutional right to counsel;
- Work collaboratively with attorneys, investigators, social workers, client advocates, and other members of a holistic defense team;
- Gain insight into the intersection of criminal law, social services, and community resources through the Office's Holistic Defense Model; and
- Participate in professional development opportunities designed to enhance students' legal research, writing, litigation, advocacy, and professional skills.

The internship is designed to provide students with an understanding of the important role public defenders play in protecting constitutional rights, promoting equal justice, and ensuring that every client receives zealous, effective, and compassionate representation.

Orleans Public Defenders are seeking 1Ls and 2Ls!

OPD is accepting applications for the Summer Law Clerk program. OPD's mission is to fight for our clients by providing excellent client-centered representation, reforming the system and partnering with the community. OPD is committed to representation that respects the humanity and dignity of those within the criminal legal system.

OPD's Summer Law Clerkship is an intensive 10-week, hands-on program. Law clerks assist attorneys in all aspects of criminal litigation including performing legal research, conducting factual investigation, drafting of memoranda and motions, analyzing discovery materials and preparing briefs.

Law clerks are required to abide by OPD's confidentiality policy, and to act at all times in the best interest of OPD's clients. Law clerks may be asked to do everything a staff attorney does for a client on a case short of speaking on the record in court. This may include, but not limited to:

- Legal research on a wide range of issues arising from the 4th, 5th, 6th and 8th Amendments;
- Writing memos, motions and writ application to the Fourth Circuit Court of Appeals and the Louisiana Supreme Court;
- Visiting clients in jail, meeting with clients' families and/or defense witnesses both in and outside of the office;
- Investigating with the attorney, i.e. going to the crime scene, canvassing neighborhoods, interviewing complainants;
- Assisting attorneys at trial and substantive motions hearings;
- Digesting discovery and pretrial hearing transcripts;
- Observing during client counseling and plea negotiations.

The Summer Law Clerkship program runs from early June through early August.

Founded in 2019, Kalamazoo Defender is a non-profit public defense organization that fights for justice in the courts, care in the community, and dignity in the world. We are a holistic defense organization that takes a client-centered approach, aiming to assist clients not only with their legal challenges, but also some of the root causes of the challenges they are facing by connecting them to additional services in the community. We have a team of 67 (and growing!) working towards our mission.

The State of Michigan has a court rule, MCR 8.120, that allows law student Fellows in the public defense realm to appear on the record and advocate for clients under the supervision of a licensed attorney.

Pairing legal Fellows with at least two attorney mentors, interested candidates can expect to gain the following experience over a 10-week summer fellowship period:

- Comprehensive orientation and training
- On the record oral advocacy
- Client contact and consultation
- Research and writing
- Collaboration with investigators, client navigators, and paralegal staff
- A fun and supportive environment to learn

We take a “the sky is the limit” approach to our Fellows, trying to integrate and include them in the office as much as they would like. Previous Fellows have joined our attorneys for community events, office social events, and made lifelong friendships and mentorships. We have had several Fellows come on to work full time with us after they have graduated law school.

We require a minimum of 35 hours per week for 10 weeks over the summer with half days on Fridays. Housing is unfortunately not currently provided. Fellows are paid \$28/hour with checks issued bi-weekly.

Kalamazoo is a mid-sized city located in Southwestern Michigan offering a diverse range of culture, experiences, and opportunities for candidates. We are located approximately 2.5 hours driving distance both from Chicago and Detroit.

The Defender Association is a non-profit public interest law firm representing over 70% of individuals charged with crimes in Philadelphia. We are committed to client-centered advocacy from arraignment through appeal, and we operate as part of a multi-disciplinary team that includes social workers, investigators, paralegals, mitigation specialists, and administrative professionals to represent the city's most vulnerable.

Our mission extends beyond the courtroom. Through Participatory Defense, expungement clinics, and community-based partnerships, we seek justice not just in legal outcomes but in the lives of our clients.

To qualify for our Rising 3L Summer Internship Program, you must be enrolled in an accredited law school and have completed the equivalent of at least 3 semesters of instruction by the summer. Our office will work with you and your law school to ensure the completion of all required documentation to become a Certified Legal Intern. As a Rising 3L Defender Summer Intern, you will have the chance to argue cases in court. Our goal is to provide participants with the opportunity to litigate various matters in court in the same manner as our first-year attorneys. Under the supervision of our office's law school clinic instructors, you will:

- Represent Defender clients at Preliminary Hearings, Motions to Suppress, and Municipal Court trials
- Draft, file, and argue motions and memoranda of law
- Interview clients via phone, in-person, and at county or state correctional facilities
- Analyze forensic evidence and draft memoranda outlining its significance to the case
- Participate in holistic representation practices to support clients with collateral consequences
- Collaborate closely with senior attorneys, social workers, investigators, and other Defender staff

As a Rising 2L Defender Summer Intern, though you will not be able to argue Preliminary Hearings, Motions, and Municipal Court Trials, you may have the opportunity to represent newly arrested clients during bail hearings at arraignment court. You will conduct client interviewing- both in the office and at the prisons- conduct legal writing assignments for various trial and pre-trial units, and have the chance to experience life as a Defender through rotations across the office's numerous practice units. 2L summer interns play an integral role at the Defender and are often asked to assist in trial preparation, mitigation, and research by senior attorneys. The 2L Defender Summer Internship is an excellent way to learn about the Philadelphia criminal legal system for those thinking about a career as a public defender. To qualify for the Rising 2L Defender Summer Internship, you will need to have completed your first year of law school by the summer.

The Colorado Office of the State defender is seeking 2Ls!

The Colorado Office of the State Public Defender offers a unique opportunity for students and volunteers to experience the work of indigent criminal defense. We offer opportunities to prelaw, current law students, paralegal students, undergraduates, and social work candidates. We are providing opportunities to 2L certified eligible law students for the BPDA Summer Fellowship program. Certified intern positions are available for law students who have completed their second year of sixty credit hours at an accredited law school. Interns are eligible for certification under Colorado's student practice rule, and have submitted the Certificate of Eligibility Form to the Colorado Supreme Court Attorney Registration Office. Certified interns are assigned casework involving misdemeanors, traffic or juvenile delinquency cases. Under the supervision of a licensed public defender, certified interns prepare cases outside of court, litigate motions, conduct pretrial and post-trial hearings and try cases to juries. The internship is an extraordinary opportunity to receive intensive courtroom advocacy experience. Summer certified interns participate in a rigorous training program before they begin their internship.

Off-summer semesters are perfect times to engage in a certified internship with any of our offices. These semesters are longer than the summer session and therefore provide you with an opportunity to establish and exercise a new set of skills that you will use in your future public defender career. Interns in the Appellate Division work on a variety of research and writing projects for attorneys in the Division under the direction of the intern coordinator. Qualified applicants must possess excellent research and writing skills and have successfully completed courses in criminal law and criminal procedure. The Appellate Division typically hosts interns after their second year of law studies.

BDS is seeking 2Ls!

BDS is a public defense office representing low-income New Yorkers in criminal, family, immigration, and civil legal matters. For nearly 30 years, BDS has worked, in and out of court, to protect and uphold the rights of individuals and to change laws and systems that perpetuate injustice and inequality. Our legal expertise work with clients is focused on the intersections of these legal systems that disproportionately impact Black and Brown communities living in poverty.

BDS represents thousands of people each year who have diverse, complex, and multi-faceted legal needs. In addition to a zealous legal defense, our interdisciplinary teams of attorneys, social workers and advocates provide a wide range of legal and advocacy services, including for housing, public benefits, education, and employment. BDS staff work collaboratively and across disciplines to deliver high-quality legal services that serve the people we represent, their families and communities.

Students in the Criminal Defense Practice Internship Program participate in a comprehensive training program that includes substantive legal training as well as practical skills training. Each intern is assigned to work primarily with at least two staff attorneys and receives intensive supervision of and feedback on their work. Common intern tasks include interviewing clients at arraignments, researching legal issues, drafting motions, and helping attorneys prepare for hearings and trial. Our student practice order enables law students to appear in court under the supervision of an admitted attorney, and most students have opportunities to appear in court.

Virginia Defenders BPDA Fellowships expose law students to all aspects of work as a Public Defender. Fellows work with mentors assigned to them in the Public Defender Office to assist with case preparation and observe misdemeanor and felony criminal trials in general district, juvenile, and circuit courts. Third-year practice-qualified students gain trial experience under the supervision of Virginia Defenders attorneys.

Virginia Defenders Fellows have daily contact with a wide spectrum of agencies involved in the criminal justice system as well as meeting with bondsmen, probation officers, magistrates, Commonwealth Attorneys, police officers, substance abuse counselors, and clients in the course of their duties. Additionally, Virginia Defenders fellows may also interview clients, perform legal research, assist with the investigation, and visit various correctional centers, the Virginia Appellate Courts, the Division of Forensic Science, drug courts, and substance abuse treatment facilities.

Virginia Defenders Fellows without third-year practice certificates will make \$18/hour, while Virginia Defenders Fellows with third-year practice certificates will make \$22/hour.

Fellowship will last 10-12 weeks.

CPCS is seeking 2Ls and 3Ls!

CPCS is the state agency in Massachusetts responsible for providing an attorney when the state or federal constitution or a state statute requires the appointment of an attorney for a person who cannot afford to retain one. The agency provides representation in criminal, delinquency, youthful offender, family regulation, guardianship, mental health, sexually dangerous person, and sex offender registry cases, as well as in appeals and post-conviction and post-judgment proceedings related to those matters. The clients we represent are diverse across every context imaginable and bring many unique cultural dimensions to the matters we address. This reality creates a critical need for CPCS staff to be culturally competent and able to work well with people of different races, ethnicities, genders and/or sexual orientation identities, abilities, and limited English proficiency, among other protected characteristics. Summer Fellows will work closely with attorneys, Social Services Advocates, and Investigators by providing legal representation and advocacy to indigent clients who are charged with criminal offenses in both the District and Superior Courts. Trial offices will provide Summer Fellows with a wide range of opportunities, including, but not limited to, legal research and writing, arraignment and bail advocacy, second seating trials, pretrial investigations including visiting crime scenes, locating and interviewing witnesses. The 10-week program will award a stipend of \$7000 or more (based on the minimum wage in Massachusetts at the time of the fellowship).

CENTRAL REGION

The Central Region is famous for its rich history. Boston is not only the capital of the Commonwealth but one of the oldest municipalities in the United States and the scene of several significant events in the American Revolution, such as the Boston Massacre, the Boston Tea Party, the Battle of Bunker Hill, and the Siege of Boston. It was a port and manufacturing hub and a center of education and culture, as well as home to the first public park, public school, and subway system in the United States. The area is home to professional sports teams, including Boston Bruins, Boston Celtics, and the Boston Red Sox. Roxbury is known to serve as the "heart of black culture in Boston" and is home to an extremely diverse population. The city of Quincy is recognized as the "City of Presidents" as it was the birthplace of John Adams, and his son John Quincy Adams, as well as, John Hancock, who was president of the Continental Congress and first signor of the Declaration of Independence, and first and third governor of Massachusetts. This city was home to the first commercial railroad in the United States and had a thriving granite industry. The Central Region of CPCS includes Public Defender Division office locations in Boston, Roxbury, and Quincy.

The Law Student Rural Public Defense Fellowship (RPDF) is an intensive 10-12 week, hands-on experience. Fellows will be placed in a supportive, active public defense office in one of Washington's rural or underserved communities. Fellows will be paired with experienced and dedicated public defenders who will provide mentorship.

Fellows can expect to engage in all aspects of criminal litigation, including performing legal research, conducting fact investigations, drafting of memoranda and motions, analyzing discovery, preparing briefs, representing clients in court.

The WA state Office of Public Defense will provide intensive skills training, financial support and resources to Fellows and their mentors.

Benefits of the Rural Public Defense Fellowship include:

- Real-world training including court and client experience
- Placement in an underserved community with unique challenges and opportunities
- Opportunity to gain extensive understanding of criminal law and procedure and develop practical expertise beyond the level offered in law school courses
- Invaluable experience to prepare for a career in public defense
- Housing Stipend up to \$900 a month for three months
- Financial compensation of up to \$28 an hour (40 hours/week)

Who qualifies for the RPDF:

- Rising 3rd Year Law Students who have completed 2/3 of their law school's 3-year program.
- Recent J.D. graduate (9 months or less) from an approved law school who has not been admitted to practice in any state or territory.
- Willing and able to relocate to one of Washington's rural communities and work 40 hours/week for 10-12 weeks.

King County Department of Public Defense is seeking 2Ls!

The Department of Public Defense (DPD) is actively recruiting 2nd year law students to participate in a 10-week internship beginning in June. Students with a Rule 9 license can appear on the record, under supervision. DPD's internship program gives students meaningful opportunities to engage directly with clients and to appear in court with the support of experienced public defenders.

DPD represents indigent clients in several practice areas: criminal defense (felonies and misdemeanors), juvenile defense, family defense, involuntary civil commitment, sex offender commitments, and contempt of court. Most students will be offered an internship in a single practice area and should express any preference in their cover letter.

Job Duties

Assist attorneys and appear on the record at: arraignment hearings; pretrial hearings; motion hearings; sentencing and probation review; or, if placed in civil practice areas, other hearings relevant to that practice (shelter care, review hearings, etc.). Assist with trial preparations (DPD makes an effort to provide but cannot guarantee trial experience). Communication with clients as well as social workers, service providers, and other individuals involved in a client's case. Other duties as requested.

Experience, Qualifications, Knowledge, Skills

By June, the student will have completed two years of law school and be enrolled and in good academic standing at an American Bar Association approved law school. Able to qualify as a Rule 9 Licensed Legal Intern, under the WSBA rule. A demonstrated interest in representing indigent persons. Possess good moral character and fitness to practice law (APPs 20-24).

Effective writing and communication skills. Organizational and problem-solving skills. Initiative and accountability for work product or service. Ability to follow oral and written instructions. Ability to maintain confidentiality. Knowledge of the operation of standard office equipment that may include personal computers, copiers, and fax machines. Ability to multitask and self-direct in a fast-paced environment.

Multilingual skills are a plus. Completed at least one of the following courses: evidence, criminal procedure, and a clinical or trial advocacy course.

Applications are reviewed on a rolling basis. To be considered for this opportunity, applicants must complete both the BPDA Law School Fellowship application and the [King County Department of Public Defense application](#). Applicants who do not complete both applications will not be considered.

The Federal Public Defender for the District of Oregon is seeking students for our Law Clerk Program. Our Law Clerk Program introduces law students to federal criminal defense work under the mentorship of experienced federal public defense attorneys.

The Federal Public Defender represents people who cannot afford a private federal criminal defense attorney who are charged with federal crimes, including bank robbery, gun and drug crimes, immigration violations, and various frauds. The Federal Public Defender is committed to the pursuit of justice through zealous advocacy in federal court for the constitutional rights and inherent dignity of individuals who are accused or convicted of crimes and cannot afford their own lawyer.

We advance the rights of all individuals by developing innovative approaches in our representation that promote systemic change and by serving as a valuable resource to the larger legal community. We know that a diversity of experiences and perspectives enhances our work. Therefore, we invest in recruiting, training, and retaining colleagues who demonstrate experience with, knowledge of, and sensitivity to the needs of culturally diverse and oppressed populations.

Law clerks assist the defenders by researching legal issues and drafting trial memoranda, motions to suppress, jury instructions, appellate briefs, and other legal writing. Typical research topics involve search and seizure issues, the right to counsel, outrageous government misconduct, evidence questions, and constitutional issues in habeas cases.

In addition to the research and writing, clerks also learn from observing proceedings in the U.S. District Court and the Ninth Circuit, and to attend attorney staffings, meetings, and moot court arguments. Students also help interview clients and negotiate cases on the monthly violation and misdemeanor docket.
